AN ORDINANCE APPROPRIATING for all road purposes for the **HOMER TOWNSHIP** Road District, WILL County, Illinois, for the fiscal year beginning **April 1, 2018**, and ending **March 31, 2019**.

BE IT ORDAINED by the Board of Trustees of **HOMER** Township, **WILL** County, Illinois, as follows:

CERTIFICATION OF BUDGET / APPROPRIATION

IN ACCORDANCE WITH CHAPTER 35 SECTION 200/18-50 ILLINOIS COMPILED STATUTES*

*35 ILCS 200/18-50: The governing authority of each taxing district shall file with the County clerk within 30 days of their adoption a <u>certified copy</u> of its appropriation and budget ordinances or resolutions, as well as an <u>estimate, certified by its chief fiscal officer, of revenues</u>, by source, anticipated to be received by the taxing district in the following fiscal year. If the governing authority fails to file the required documents, the county clerk shall have the authority, after giving timely notice of the failure to the taxing district, to refuse to extend the tax levy until the documents are so filed.
