TAX LEVY ORDINANCE

HOMER TOWNSHIP ROAD DISTRICT

ORDINANCE NO: HTRD-111918

An ordinance levying taxes for all road purposes for the Homer Township Road District, Will County Illinois, for the tax year 2018, collectable in 2019.

BE IT ORDAINED by the Board of Trustees of Homer Township, Will County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of the Homer Township Road District on November 19, 2018 does hereby determine and declare that the sum of Four Million, Eight Hundred Fifty-Three Thousand, One Hundred Eighty-Five Dollars (\$4,853,185.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all of the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

Road and Bridge Fund Building and Equipment Fund

For the year 2019

SECTION 2: That the amount levied for each object and purpose shall be as follows:

ROAD and BRIDGE FUND

\$ 4,235,113.00

EQUIPMENT and BUILDING FUND

\$ 618,072.00

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of Will, on or before the last Tuesday of December, 2018 a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

ADOPTED this 19th day of November 2018, pursuant to a roll call vote by the Board of Trustees of Homer Township, Will County, Illinois.
